1. Grievance Submission:

In case of any grievance, an ineligible candidate must submit an application on prescribed proforma available at HED website alongwith substantial supporting documents (in hard form) in R&I Branch, Higher Education Department, Old DPI Building, New Anarkali, Lahore before **05:00 PM** on **20.05.2026 (Wednesday)**.

2. Time Limitation:

No application or representation shall be entertained after the stipulated date and time i.e. **05:00 PM** on **20.05.2026** under any circumstances.
