1. Grievance Submission:

2. Time Limitation:

No application or representation shall be entertained after the stipulated date and time i.e. **03:00 PM** on **10.03.2026** under any circumstances.

3. Shortlisting for Interview:

Out of eligible candidates, only top candidates strictly in order of merit shall be called for interview before the Search Committee.
