2. The appointment of the above-mentioned candidates is made subject to the following conditions, in addition to terms and conditions already accepted by them.


- i. They shall assume their duty at the place of posting within 15 days, positively.

- iv. No request regarding their transfer shall be tenable during the initial 2 years of their appointment.
