2. **AND WHEREAS,** the undersigned is of the opinion that it is not necessary to hold an inquiry into the matter in view of the provisions contained in Section 5(1)(b) of the Act *ibid.* It is, therefore, proposed to proceed against you under Section 7(b) read with Section 5(1)(a) of Punjab Employees Efficiency, Discipline and Accountability Act, 2006.

3. **NOW THEREFORE,** you are hereby called upon to show cause in writing **within seven days** of receipt of this notice as to why one or more of the penalties as prescribed under Section 4 of the Punjab Employees Efficiency, Discipline and Accountability Act, 2006 should not be imposed upon you.

4. Your reply to this show cause notice should reach to the undersigned within the said period, failing which it shall be presumed that you have no defense to offer.

5. In case you desire to consult any record, on which the aforesaid charge(s) are based or is relevant to the aforesaid charge(s), you may do so with prior arrangement with the undersigned **within seven days** of the receipt of this notice.
